The Pauls Valley Farmers Market is a 100% Oklahoma Grown and Made market.

All items must be made or grown in Oklahoma.

Foods must be prepared in accordance to the Oklahoma Health Department standards.

Dates of Attendance

Vendors must commit to attend all the dates within a scheduled “market season” for which they apply. Absences may be approved in advance by the market manager, failure to obtain approval will result in the loss of future spaces and dismissal from the market. In the case of an approved absence, the space will go to a vendor on the waiting list to fill the space.

Location

The Pauls Valley Farmers Market will be located under the pavilion at the Santa Fe Depot in downtown Pauls Valley. The address for this location is:

Guidelines of Acceptance

Because there is a limited amount of space in the market,

not every applicant will be accepted. Priority will be given to vendors that create the correct balance at the market, at the discretion of the board of directors. Vendors are required to provide their own tables/ chairs for under the pavilion. A limited amount of vendors will be allowed to use the back of a truck for vending purposes, at the discretion of the board.

Fees

Each vendor will pay a seasonal association fee of \$50 in order to be included in the Pauls Valley Farmers Market. This fee will cover many market costs as well as permit vendors a vote at board meetings. Additionally, each vendor will pay a daily space rental fee. First year vendors will pay \$5 a space for the duration of the season.

Market space will be assigned in advance by the market manager. Vendors will be assigned space, size, and location based on space availability, vendor needs, and best fit for the market as a whole. Space location assignment will vary from season to season and from Tuesday to Saturday markets.

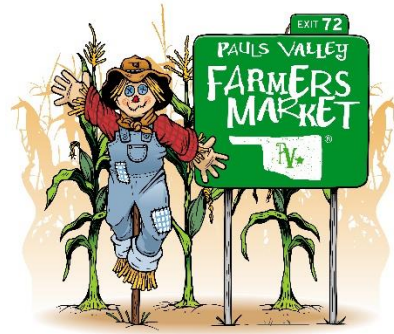
