Pauls Valley, OK Specific Information:

-City Hall: City Hall will be closed to public access. The billing office will remain open. The City has multiple ways to pay a utility bill, court fine, permit, etc. For additional options please contact the Utility Billing Clerk at 405-238-1300 or 405-238-3308. All other city services will run as normal.

- Restaurants/Businesses: Currently no Pauls Valley businesses or restaurants have closed due to COVID-19. As a preventative measure, customers should consider utilizing curbside services.

Church Denominations: Please contact your denomination for future services.

-Water Bills: Effective immediately there will be no disconnection of water service to customers due to non-payment for the March 26 disconnect day. Additionally, the \$20.00 service disconnection fee will be waived for accounts that would have been disconnected on March 26th due to non-payment. Customers are still responsible for their bill and need to keep their account in good standing by paying their bill or making a payment arrangement.
