

RESOLUTION NO. 1020

A RESOLUTION CALLING AND GIVING NOTICE OF GENERAL AND RUN-OFF ELECTIONS TO BE HELD FOR COUNCIL POSITIONS 1, 2, 4 AND 5 ON THE CITY COUNCIL, CITY OF PAULS VALLEY, OKLAHOMA; ESTABLISHING THE FILING PERIOD FOR SAID ELECTION; ESTABLISHING THE QUALIFICATIONS FOR CANDIDATES; ESTABLISHING THE FORM OF ELECTION AND STATING THE APPLICABLE LAWS FOR SAID ELECTION.

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PAULS VALLEY, OKLAHOMA:

- 1. A General (non-partisan) Election for positions on the City Council of the City of Pauls Valley, Oklahoma, if needed, shall be held on Tuesday, April 6, 2021; a Run-Off Election for positions on the City Council of the City of Pauls Valley, Oklahoma, if needed, shall be held on Tuesday, September 14, 2021.**
- 2. The following positions shall be elected at large for four (4) year terms:**


Council Place 4	Expiring 2025
Council Place 5	Expiring 2025
- 3. The following positions shall be elected at large for two (2) year unexpired terms:**

Council Place 1	Expiring 2023
Council Place 2	Expiring 2023
- 4. The filing period for the above-referenced election shall begin at 8:00 a.m. on Monday, February 1, 2021, and ends at 5:00 p.m. on Wednesday, February 3, 2021.**
- 5. The qualifications for said offices are as follows: Each councilman must be at least twenty-five (25) years of age, an elector of the city, not in litigation with the city nor in arrears for city taxes when elected, and not the owner of stocks or bonds of any public service corporation doing business in the city, and must, for two (2) years next preceding the date of his election, have been a bona fide resident and property taxpayer of the City of Pauls Valley or territory legally annexed thereto. Council members may reside anywhere within the city without regard to ward boundaries.**

- 6. The election will be non-partisan, and no party designation or emblem shall be placed on the ballots.
- 7. The provisions of the state constitution and law applicable to city elections, shall govern said election insofar as they are superseded by the specific provisions of the Charter of the City of Pauls Valley, Oklahoma regarding date of election, type of elections, election at large, and candidate qualifications set out hereinabove.




